

## INTERNATIONAL JOURNAL OF BODY COMPOSITION RESEARCH (IJBCR) AUTHORS' GUIDELINES

### Scope of the journal/editorial policy.

IJBCR is a peer-reviewed journal (first issue March 2003) offering early publication of original research reports, short communications, review articles, and letters to the editor (<500 words). IJBCR aims to promote knowledge and development and to stimulate knowledge-based discussion. Contributions are welcome on all relevant aspects of physics and methodology, biology, medicine and public health, and appropriate studies in animals and animal sciences. For further information contact the editors (below).

### Conditions of publication

Papers are accepted for publication on the understanding that the content is original, has not been published and has not been – nor will be, while under offer – submitted elsewhere. The submitting author warrants that all authors are in agreement and responsible for publication. The authors are responsible for obtaining permission for the re-use of any copyright material. The manuscript should specifically note appropriate steps taken to conform to human and animal research standards and other ethical requirements including the existence of any conflicting commercial interests. Copyright is transferred to the publisher upon publication. Note that the publisher does not require the author to request permission for use of individual items (eg figures) elsewhere but does require acknowledgement of the journal. Authors may copy the paper for their own teaching use.

### Submission of papers for publication

The paper should be sent to the editorial office (see foot of page). The following are required: (a) three copies of the manuscript (including at least two copies of the Figures in printable form); (b) e-mail copy; (c) diskette (see 'Disk presentation', below). If you are easily able to send (a) and (c) without delay please do so. The editor may request (b) subsequently.

### Preparation of the manuscript and style

### Main text features and style

The presentation of the paper should follow that of scientific journals eg as to the normal section headings and type layout (A4 etc) and the Vancouver style. IJBCR will observe both US and UK spelling and authors should be consistent with either Merriam-Webster's Collegiate Dictionary or editions of the Oxford Dictionary (please note the verb ending -ize is preferred, and both unnecessary capital letters and stops are avoided, thus government not Government, eg not e.g.). Use SI units where possible. Do not hesitate to explain units that may not be familiar to all readers (especially if non-SI). Spell out abbreviations only at first use in text. Take care to use and explain all use of trade names or products.

### Title page

Give title of paper (fully informative but concise); full name of the authors (use initials rather than first names and follow the style in which you expect to be indexed); below, list each author's name again followed by degrees and place of work and end with the name and address of the corresponding author.

### Abstract and key words

Describe (<250 words) aim, principal procedures, findings. Do not include references. List up to 10 key words or phrases. Do not repeat same text as part of paper itself!

### References

Cite in numerical order in text inside square brackets, eg [1, 17–24, 77]. List references by number at end of text (more than three authors may be cited as Jones, Howe, Lee et al). Unpublished and personal references appear only in text.

### Tables

Tables should be set out on separate pages, with their title above, and numbered in sequence in which they appear (Table 1, 2 etc). Do not duplicate text. Place supporting information in title. Define units in footnotes using <sup>a,b,c</sup>. Use \* \*\* for probability.

### Figures

Make sure that large Figures will be satisfactory when reduced to print. Examine especially lettering and scales for size. If supplied electronically graphics should be saved as high resolution (at least 300 dpi) files saved as .eps or .tif format. Do not submit colour figures. List Figure titles on a separate sheet. Indicate abbreviations and units. Acknowledge sources of published figures. Permission to reproduce the work of others is the author's responsibility. Make sure lettering is both correct and consistent with text.

### Disk or e-mail

If submitting by e-mail please date the version and send a covering message identifying the software programs used including those used for Figures. Make paper copies that you also may send 100% consistent with the electronic one.

### Proofs, offprints and page charges

Proofs will be sent to the corresponding author by mail or e-mail PDF file, together with an order-form for offprints. There are no page charges.
